2. Introduction

Transitory accommodation is defined as properties, either whole units or dwellings or a specific room or rooms within a unit or dwelling which are offered for short term residential rental, being rental for a period of less than 28 days, at any time during the 2019/20 financial year.

The Tourism and Economic Levy has been introduced to fund the Noosa Local Economic Plan, including the promotion of tourism, through the levying of a special rate. Council's Revenue Statement states that the levy shall apply to all land that receives a benefit from tourism, either directly or indirectly. The full Revenue Statement can be viewed on council's website.

The special rate applies to all rateable land that has been categorised in accordance with the table below, subject to a minimum amount, in accordance with *Section 94 (10) of the Local Government Regulation 2012*. A copy of the Tourism Levy Overall Plan can be obtained from council's website.
