Shaded areas in vehicle depiction represents volume of waste i.e. Small, Medium & Large. For disposal charges refer to the coloured columns for the relevant waste type.




Note: Vehicles other than those depicted below and or are exceeding 500 kgs net, (pay load) are charged by tonne or cubic metre.

Green Waste (pro-rata per tonne) – any vehicle not described above, green waste and vegetation excludes palms & tree trunks with greater than 30cm diameter	\$50.00
Construction & Demolition Waste (pro-rata per tonne or part thereof) – any vehicle not described above, includes clean & missed timber. For all loads of material that were initially accepted and charged as clean C & D Waste and subsequently suspected of being contaminated, No refund will be applicable to the customer who chooses to remove the load from site.	\$243.50 or part thereof
Mulch Fee – at any time up to 3m3 single ground mulch is available to all domestic customers without charge if self-loaded or loaded free if machine is available	\$0.00
