

The important stuff!

Who can apply?

To be eligible for funding your organisation must be a legal not-for-profit organisation as defined by the Australian Taxation Office (ATO) and Australian Charities and Not-For-Profits Commission (ACNC)*

- When is funding available?
- There are 2 rounds per year:
 - Round 13 open 18 February and close 25 March 2020
 - Round 14 open 10 August and close 24 September 2020
- What funding is available?
- The minimum grant amount from Council is \$1,000 and maximum grant amount is \$30,000*
- When will I know if I have been successful?
- Approximately 12 weeks from closing date.
- How do I apply?
- Applications must be submitted online.
- Applicants must speak to a Council officer to discuss their project PRIOR to starting an application.

Overview of the fund

Approximately \$55 million per year, split between five funding rounds.

Closing dates: 28 February, 30 April, 30 June, 31 August and 31 October.

Applications will be considered for funding between \$500 to \$35,000

Plan

Read the funding guidelines – each round!

Decision – Is my organisation <u>eligible</u>? It must ...

Have not-for-profit objectives

Be incorporated or registered by an Act of Parliament

Have an active ABN

Has a bank account in the name of the legal entity

If sponsoring, accept financial and legal responsibility for the application and grant.

Decision – Is my organisation ineligible? Yes if it is ...

Proprietary limited or public companies limited by shares

Individuals or organisations trading for profit

CHANGES: State, private and independent schools are ineligible to apply in the own right or sponsored organisation.

Application eligibility – note changes!

.

- An organisation cannot submit a new application while awaiting the outcome
 of a previously submitted application (i.e. you cannot submit applications in
 multiple rounds).
- Organisations are excluded from submitting an application for one round from the date that OLGR has notified them that their previous successful application is considered closed.
- Legal entities can only apply in their own right or sponsor one application within the same physical location

Ineligible budget items

- Items purchased before the grant is approved.
- Grant writer and project management fees.
- Purchase of equipment/services that benefit an individual
- Repayment of debts and loans.
- Overseas travel
- Items purchased overseas unless prior approval obtained.
- Goods or services that benefit an individual.
- Gifts, Prizes, Alcohol

Refer to the funding guidelines for a complete list.

Decision - Consider the funding priorities:

- Priority 1 Organisation affected by natural disaster
- Priority 2 Facility improvements or equipment
- Priority 3 Vehicles (bus, car, caravan, boat etc)
- Priority 4 Community events, training, workshops, programs and festivals
- Priority 5 Organisations that have received GCBF funding of \$15,000 or more in the last 2 years.

Assessment

Your application will:

Be assessed against the funding guidelines.

Be presented to the Gambling Community Benefit Committee for consideration and recommendation (eligible only).

Be provided to the Attorney-General for consideration and approval (recommended only)

Receive an outcome approximately five months after the closing date.

Plan, Plan, Plan

"No one sets out planning to fail, but sometimes priorities (too many) or time (not enough) or self-discipline (lack of) results in our failing to plan which can make all the difference between an awesome victory and a tragic loss"

Before you apply - Get Organised.

You have a great idea for a project - now get organised! A project plan is a great place to start.

- Why does this project need to happen? Why is it important?
- Who can help you? Who's involved?
- Do you have the support of your committee/team is it outlined in your business or strategic plan?
- How are you going to achieve this?
- What are the key milestones and dates for the project?
- What are the expected costs, before, during and after the project delivery

Start small and early!

02

Research

By researching and obtaining evidence for your project you can show the funder you have identified a need for your project in the community

- Engage with your community, members and volunteers
- Research the grant provider what projects have they funded in the past? Connect with the successful group ask questions!
- Find statistics and data out there that support your objectives. What permissions and consent do you need? For example, Solar panels on a club house who owns the building and what approvals do I require. Will they support this project?

Identify all potential funding sources - how much do you want and from who?


Now you have your project outlined, how are you going to fund it?


Funding is competitive so it is wise not to rely on a single source.

Consider:

- Other grants
- Crowdfunding
- Club savings
- Fundraising
- Sponsorship
- Membership fees

DON'T PUT ALL YOUR EGGS IN ONE BASKET





Get to know the funding provider

- Make sure you are a good fit the funders interests should match well with your organisations mission
- Read their grant guidelines
- Check the eligibility criteria is your organisation and project eligible? Check eligible funding items
- Contact the funder write down your questions beforehand. The more connection you have with potential funders, the more likely you are to receive the grant
- Check what projects they have funded before. What does that organisation like to fund?
- What are the grant priorities and assessment criteria?

Application time!

Be clear, concise and to the point

Communicate well.

- It is a myth that grant readers want to be dazzled by fancy jargon and contemporary literary prose. Use simple. effective language.
- Grant readers want to understand your project the who, what, why, how, when and how much! They prefer not to read through pages and pages to find the key points.
- Tell your (powerful) story but stay relevant. Be passionate without waffling.
- Don't assume the reader/assessor knows all about your organisation.

 Provide a few clear statements about what your organisations does and their outcomes/achievements.

Aligning to the funding priorities/guidelines

- Again, when writing your application, make sure it aligns with the grant/funding priorities. Re-read the guidelines and check again what the provider is wanting to achieve.
- Is there a strategy or plan the funding provider is wanting to deliver on? Eg. Noosa Council's Social Strategy or The Queensland Sport and Active Recreation Strategy 2019–2029.



Project:

Upgrade of toilet and change-room facility at local ABC Football Club

Answer 1

The club needs to upgrade the toilet/change room block because it is old and smelly and looks terrible for members and vistors.

Answer 2

The toilet/change room block at our facility is extremely old and run down, decrepit, shabby - reflecting a ramshackle of a building. It has been in existence for an eternity and not currently meeting our needs. We have over 100 members and they constantly complain to us how foul, abominable, repugnant and hideous the toilet facilities are. We have great plans for when we achieve an upgrade. Loads of people will be involved in the project, we will hold information sessions followed by working bees to get it done.

Answer 3

The ABC Football club project is to upgrade our current toilet facilities that are no longer meeting our clubs needs. The fa cilities are approx. 30 years old with original plumbing and have a range of health and safety issues. Our club has a growing membership w ith 21 % increase in women and girls membership in the last 2 years. Our club has potential to host more visiting teams and regio nal carnivals and the upgrade will assist with our growing club. The upgrade will include new toilets, basins, flooring, showers , benches painting and plumbing. It will be done by local, experienced and qualified trades - persons within a 3 month time - frame.

DEMONSTRATE CAPACITY TO DELIVER

Don't forget to tell them who is involved and the experience they have - what projects they have managed before?

Do you have all the available resources to deliver this project?






SUPPORTING YOUR APPLICATION

Demonstrate support for your application and project by:

- Letters of support from those who will benefit in the community from your project
- Letter of support from project partners
- Evidence of relevant permissions/permits/approvals
- Photographs
- Business/Strategic plans that mention your project
- Surveys, reports, extracts

Project:

Upgrade of toilet and change-room facility at local ABC Football Club

PREPARE A DETAILED BUDGET

- Identify all costs related to the budget
- Be clear on eligible items in your budget check what item you are requesting is an eligible item
- List all sources of income e.g. sponsorship's, ticket sales, your own contribution (in-kind), discounts from suppliers
- Make sure your income and expenditure balance
- Check eligibility criteria and if/how many quotes are required to be obtained and uploaded. It may make your application ineligible if you don't provide what they ask for
- Make it realistic
- Contact the funding provider if you have any questions regarding the budget - it's a very important thing to get right!



DON'T LEAVE IT TO THE LAST MINUTE

- Check the closing date and time is it Eastern Standard Daylight Savings Time?
- Allow time to to gather all the requested information
- Allow time to ask questions with an hour to go the person you may need to speak to may not be on-hand
- Allow time to troubleshoot technical errors/hiccups
- Submit before the deadline make sure you receive a 'confirmation of submission' email.
