RESEARCH STUDY SUMMARY

ABOUT PLACE SCORE

Place Score offers two sophisticated data collection tools, Care Factor (CF) survey and Place Experience (PX) Assessments.

Like a 'place census', Care Factor captures what your community really values, while PX Assessments measure the community's lived place experience.

Together they help you identify what is important, how a neighbourhood is performing, and what the focus of change should be. An attribute with a high CF but a low PX should be a priority for investment as it will have the most positive impact on the most amount of people.



THE DATA

Between 3 November and 5 December 2021, Place Score, on behalf of Noosa Shire Council, collected online surveys:



1,655 people shared their values (CF)



1,452 people rated a neighbourhood (PX)



1,240 ideas for change were collected

These community insights are the basis of your Liveability Study, which identify key investment areas for the LGA, by neighbourhood and for key demographic groups.





EXECUTIVE SUMMARY (1/3)

YOUR COMMUNITY VALUES

The Noosa community aspires to have neighbourhoods that feature unique natural environments that are well protected.



Neighbourhoods that offer shared community amenities, like local shops within walking or cycling distance.



Neighbourhoods that feature locally owned and operated businesses that provide the community with their daily needs.



Neighbourhoods that provide an attractive and high quality environment that people can be proud of.

YOUR NEIGHBOURHOOD PERFORMANCE

The Noosa LGA received an average score of 70/100; two points higher than the National Benchmark Average. Kin Kin, Noosa North Shore and Cooran are the only neighbourhoods performing under the national average.



Every neighbourhood received a positive NPS, meaning residents are likely to promote and recommend their area to others (LGA average of +41). Residents of Pomona have the highest NPS across the LGA with +53!



LIVEABILITY SNAPSHOT


On average, Noosa LGA has more liveability contributors than improvement opportunities. In other words, the LGA's neighbourhoods are performing well where it matters most.

The LGA especially meets community members' values regarding the local economy and environmental sustainability.

However, some highly valued aspects of a neighbourhood can still be improved. These top improvement opportunities are associated with movement, open space and management and safety.

All Place Attribute associated with social facilities and services are classified as improvement opportunities.

Note: Although the are no Place Attributes at the LGA level that are classified as the highest level of priority (Prioritise), this is not the case for every neighbourhood. A neighbourhood breakdown can be found on pages 16-20 of this report and on your Liveability Platform.

This ideal neighbourhood features a strong economy with locally owned and operated businesses that provide the community with their daily needs.


It offers a sense of safety and diverse community amenities within walking or cycling distance.

The Care Factor survey asks respondents to select what is most important to them in their ideal neighbourhood in each of five Place Dimensions. The Place Dimensions and associated Place Attributes reveal what attracts and attaches people to a neighbourhood, as well as the barriers to entry or connection.

The LGA top 15 Care Factors are ranked based on how many people selected each attribute as being important to them in the 'ideal neighbourhood'.

NEIGHBOURHOOD LIVEABILITY


On average, Noosa's neighbourhoods scored a 70/100, which is two points above Place Score's National Benchmark Average of 68/100.

The neighbourhoods with the highest levels of liveability include Noosa Heads (74/100), Coastal Communities – South (73/100), Noosaville (72/100), and Pomona (71/100).

The northern end of Noosa LGA includes some of the suburbs with the lowest levels of liveability. These include Kin Kin (58/100), Noosa North Shore (61/100), and Cooran (66/100).

A PX Assessment asks our community to rate how different aspects of their current neighbourhood are impacting their 'lived place experience', resulting in a PX Score that captures neighbourhood liveability.

We can compare how our community rated the liveability of their current neighbourhoods, and use this data to identify areas performing better or worse than the LGA average.





NEIGHBOURHOOD LIVEABILITY BY DEMOGRAPHIC

Residents of Noosa Heads aged 65+ and residents of Coast Communities – Sourth aged between 45-64 are experiencing the highest level of liveability (76/100).

On average, visitors and workers rated Noosa's neighbourhoods higher than residents (72 vs 70/100).

People under 25 have one of the lowest levels of neighbourhood liveability across the LGA, with an average score of 67/100 (5% lower than residents aged 65+).

Women in Kin Kin and Pomona experience a lower level of neighbourhood liveability than men (-8% and -7% respectively).

Conversely, men in Boreen Point and Cooran experience a lower level of neighbourhood liveability than women (-7% and -5% respectively).



MOVEMENT




Council has the opportunity to maximise community outcomes by improving active and public transport options in Boreen Point, Tewantin and Cooran. Better active connections between housing and local centres in Cooran, Cooroy and West, Tewantin, Coastal Communities – North and Pomona could also positively impact liveability.

- 'Access and safety of walking cycling and/or public transport' could be improved in every neighbourhood, with the exception of Noosa Heads, Coasta.l Communities – South and Coast Communities – North, where it it is performing well and should be nurtured.
- 'Walking/jogging/bike paths that connect housing to communal amenity' is performing well and should be nurtured in Noosa Heads, Noosaville and Coast Communities – North.
- Kin Kin and Noosa North Shore underperform in every Place Attribute associated with movement.

OPEN SPACE




Council has the opportunity to maximise community outcomes by investing in the quality of public spaces in Cooran and Coast Communities - South. Improving physical comfort in Kin Kin could also greatly improve liveability.

- The 'Quality of public space (footpaths, verges, parks etc.)' is positively contributing to liveability in Noosa Heads and Noosaville but could be improved in every other neighbourhood.
- Consider investments that provide more or better 'Spaces for group of community activities and/or gatherings' in Boreen Point and Kin Kin.
- 'Spaces suitable for play (from toddlers to teens)' is performing poorly in every neighbourhood except Coast Communities - South.
- To future proof your neighbourhoods, consider increasing the provision of public spaces in every neighbourhood except Noosa Heads, Noosaville, Coast Communities - South, Tewantin and Coast Communities - North.

ECONOMY




Council has the opportunity to maximise community outcomes by improving access to neighbourhood amenities in Noosa North Shore. There is also room for improvement for every economy-related Place Attribute in Kin Kin and Coastal Communities North.

- 'Local employment opportunities (within easy commute)' is performing poorly across Noosa. Consider partnerships that maintain and improve local employment options.
- 'Things to do in the evening (bars, dining, cinema, live music etc.)' should be nurtured in Noosa Heads, where it is highly valued and performing well. Consider improving the evening economy in every other neighbourhood.
- Managing community expectations or an uplift in the provision of day-to-day shopping in Cooran and Coastal Communities – North has the potential to impact local liveability positively.

ENVIRONMENTAL SUSTAINABILITY




Council has the opportunity to maximise community outcomes by improving the provision of landscaping in Noosa North Shore, along with encouraging more sustainable behaviours from community members in Kin Kin. Nurturing and protecting nature is central to ensuring the current levels of liveability remain the same in the future.

- Consider investing in the 'Sustainable urban design (water sensitive design, transport oriented design, sustainable building design, density etc.)' in every neighbourhood, starting with Coastal Communities – North.
- Improved management regarding the 'Protection of the natural environment' could have a significant positive impact on liveability in Cooran, Kin Kin and Coast Communities – North.

SOCIAL FACILITIES AND SERVICES



Based on the values of the overall community, there are no pressing issues regarding social facilities and services. However, these attributes are generally performing poorly, and some subsets of highly values them. Consider partnerships or projects that can improve these features.

- Investing in the 'Access to shared community and commercial assets (library, bike/car share, sport facilities/gyms etc.)' is a priority for women in Cooran and Coast Communities North.
- Family and community services, child services and local educations options are underperforming in every neighbourhood.

COMMUNITY IDEAS FOR CHANGE

Most community ideas for change relate to improving movement, open spaces, and management and safety.

The most common theme amongst community ideas is improving movement (49% of all responses). A preliminary review reveals that nearly 12% of ideas relate to walkability compared to 9% to improve car accessibility.

The second most common theme is open space, with nearly 20% of ideas relating to more or better parks, and almost 10% relating to play spaces.


Most ideas within the management and safety theme relate to improving the general sense of safety and the offer or restriction of spaces for dogs.

NOOSA COMMUNITY IDEAS FOR CHANGE BY AGE GROUP



Place Score asked the community: 'What's your big or small idea to improve your neighbourhood?' and 'What's missing in your neighbourhood that would make it better for you?'

1,240 answers were collected and classified under nine different themes. An idea can be classified in more than one theme (e.g. someone may share an idea that relates to movement and economy).

314 shared their values 274 rated their neighbourhood

5-9 years

290 shared their values 258 rated their neighbourhood

10+ years

904 shared their values 802 rated their neighbourhood



COMMUNITY VALUES

Regardless of the length of residence, community members are aligned on the importance of unique natural features and the protection of the natural environment.

The top 15 most valued Place Attributes are generally similar across the three groups.

Key differences:

- A higher percentage of residents of 10+ years selected 'Sense of neighbourhood safety (from crime, traffic, pollution etc.)' (58% vs 49% for under 5yrs).
- A higher percentage of residents of 5-9 years selected 'Access to neighbourhood amenities (cafes, shops, health and wellness services etc.)' (55% vs 45% for 10+yrs).
- A lower percentage of residents of 10+ years selected 'Walking/jogging/bike paths that connect housing to local amenity' (49% vs 57% for 5-9yrs).



NEIGHBOURHOOD PERFORMANCE

Every group shares the same average PX Score of 70/100.

Residents who moved to the Shire less than 5 years ago, are most likely to promote their area to others (NPS of +54 vs +39).

All groups rated their neighbourhoods similarly in regards to the top performers:

- Elements of natural environment (natural features, views, vegetation, topography, water, wildlife etc.)
- Overall visual character of the neighbourhood
- Sense of personal safety (for all ages, genders, day or night)
- There are people like me (age, gender, interests, ethnic backgrounds etc.)

All cohorts share the same bottom two Place Attributes (housing prices and local employment). Interestingly, long-term residents rate 'Range of housing prices and tenures' lower than any other group.



KEY FINDINGS (2/2)

COMMUNITY RECOMMENDATIONS

Unsurprisingly, as the three residency cohorts generally share the same values and ratings, their priorities are also highly aligned.

One of the most significant differences in recommended actions is around the 'General condition of public open space'. All highly value it, but long-time residents (10+ years) rated it lower than their counterparts (6.7 vs 7.2).

Other variations in strength or priority are minor and mostly relate to one group being slightly more or less aligned in their values. However, those slight changes in values do not warrant Council planning differently based on the length of residency.

The adjacent table summarises the differences in community strengths and priorities by the length of residency.
