ROAD NAMING APPLICATION



For use by land developers

Road Naming:

A name will be:

- 1. Relevant to Australian, preferably local, history, flora, fauna, culture, landscape or physical characteristics; and
- 2. Only one word, excepting personal names and understanding that a geographic relationship such as Cooroy Mountain is permissible; and
- 3. Sensitive to diverse cultures and in accordance with community standards. The use of Aboriginal and Torres Strait Islander names will be governed by the ANZLIC Committee on Surveying & Mapping *Guidelines for the Consistent Use of Place Names 2012*; and
- 4. In the style and spelling of contemporary Australian English, concise, easy to pronounce and spell and without accent marks, apostrophes or hyphens.
- 5. Names that may be construed as advertising a commercial or industrial enterprise are not suitable.
- 6. If personal names are used, the person commemorated should:
 - a) Have contributed significantly to the development of the locality or region; or
 - b) Have demonstrated outstanding levels of civic service; or
 - Have achieved role-model status in the wider community or have donated property or funds for community benefit
- 7. Road names should be unique within the area north of the Maroochy River and single destination, eg Eumundi Road, not Eumundi Noosa Road.
- 8. Road types will be in accordance with the Manual of Uniform Traffic Control Devices.
- 9. Council approval of new road names is required before a plan for subdivision is lodged.
